## **Generate Instant Prepaids at the POS**

Sites can now sell instant prepaid washes, for redemption at a kiosk terminal from a cashier terminal. Sites can use this to sell washes on rainy days, issue a rewash that doesn't require site staff intervention at a kiosk or even offer a complimentary wash if the tunnel is down. The instant prepaids are printed from the receipt printer and contain a barcode (12-character, uppercase alphanumeric), which can then be scanned and redeemed at a kiosk terminal (or cashier terminal).

### **Sell Instant Prepaids**

Instant prepaid products can be viewed and added to the cart from an auto-generated **Prepaids** tab on cashier terminals (at sites where the instant prepaid products are active).

Instant prepaid products can also be searched for and added to the cart from the cashier terminal **Sales** tab.

Like wash service products, only one instant prepaid product can be in the cart for a given sale.

Upon tendering a sale with an instant prepaid, two receipts are printed:

- 1. A standard receipt
- 2. A receipt that contains the instant prepaid barcode and code (printed directly under the barcode).

Note: Instant prepaid receipts can be re-printed from the **Sales History** tab.



### **Redeem Instant Prepaids**

Consumers can redeem instant prepaids at a kiosk terminal by scanning the barcode.

To manage control, instant prepaids used for lobby and other non-wash a la carte products cannot be redeemed at a kiosk terminal. If a consumer tries to redeem one of those prepaids at a kiosk, they will see the following screen:



Instant prepaids can be redeemed at a cashier terminal by scanning the barcode or manually entering the code in the **Manual Entry** modal and then selecting **BARCODE**.



## View Transaction History from the Essential Web App (EWA)

Car wash consumers are now able to view both their EWA and site purchase transaction history through the EWA.

After logging in to the EWA, select the menu icon in the top right corner. The main menu appears with a new **Receipts** option.



Upon selecting the **Receipts** option, a new **Receipts** screen appears.



- Users can see any non-zero transaction linked to them as a customer, with their 50 most recent transactions loaded on the screen.
- The transactions are sorted by date/time, beginning with the most recent transaction at the top of the list.

Each transaction card includes the following information:

- Date/time displayed in current device's time zone
- Total amount paid or refunded
  - $\circ$  If the transaction is a refund, a plus sign "+" appears before the amount.
- Plan name, wash name or "Transaction"
- PLAN or WASH tag (if applicable)
- Description if it's not a general transaction (i.e., "Purchase", "Reload", "<N> vehicle(s) added" or site name)
- Payment method
  - $\circ~$  Payment methods displayed: credit card, cash, gift card and check
    - If payment method is credit card, the number is masked
  - o If multiple payment methods were used, "Mixed payment" is displayed

Details included on the transaction cards vary based on transaction type.
